Please be informed that in order to improve the quality of the services of the website <https://polczfood.com/> (hereinafter referred to as "the website"), to facilitate the use of the website and, with your consent, for the purpose of analysing your visit and displaying online advertising, we use cookies. You can read below about cookies in general and then about the processing of data by cookies on our website.

### **2. About cookies in general**

#### **2.1. What are cookies?**

A cookie is a small piece of data (a packet of variable, alphanumeric information) that is sent to your device by the server of the website you are browsing. The cookie is stored in the browser program of your computer, phone or tablet and can be read later by the sending server. The cookie cannot be read by any website other than the one that placed it. Cookies tell us about visitors' habits when using the website. Cookies can be used for a variety of purposes, such as to measure the number of visitors to the site or to facilitate browsing by remembering pages previously visited within the site. No cookie contains any personal information that would directly

enable anyone to contact you by email, telephone or traditional mail. Cookies are not in themselves capable of identifying the user, but only of recognising the visitor's device. If you do not wish to accept the use of cookies on the site, you can set your web browser to inform you of the placement of cookies or to prevent the placement of cookies.

Functions such as cookies can also be implemented by tools that are not considered cookies in the IT sense, because they only partially meet the above description. However, from a data protection and data management point of view, the rules applicable to cookies must also be complied with when using such tools, so the term cookie used in this document should be understood to include such additional tools.

## 2.2. How can you control how cookies work?

We place cookies on the device you use to visit our website (your computer, phone or tablet). We will inform you of this when you start browsing our website, in a pop-up window when the main page loads.

We do not need to obtain your consent to place cookies to provide the functionality and convenience of our website. We need your consent to start using cookies that identify your device, those used for anonymous visit analysis and those used for data collection for marketing purposes. Your consent is requested in the pop-up window mentioned above. You can call up this window at any time by clicking on "Cookie settings" at the bottom of the page, and you can change your consent to each collection at a later date.

You can choose to disable and delete cookies in your internet browser settings at any time, regardless of the settings we provide above. Please note, however, that without the use of "necessary/functional" cookies, you will not be able to access many of the features that make your browsing experience easier, or some of our services may not function properly.

## 2.3. Managing cookie settings in browsers

You can change your cookie settings in the pop-up window or via your browser. You can disable the use of cookies by activating a setting in your browser that allows you to refuse all or some cookies. These settings are usually available in the "settings" or "preferences" menu of your browser. Use the following links to find out more:

## 2.4. Types of cookies

Cookies can be either session cookies - cookies that are valid at the time of processing - or persistent cookies - cookies and we distinguish between first-party (internal) and third-party (external) cookies. Below you can read what these terms mean to help you better understand the cookies we use and why we use them.

## 2.5. Cookies valid during your browsing session

Cookies that are valid during a browsing session allow you to be recognised during your visit to our website and therefore any page changes or selections you make from page to page within the website can be remembered by the browser. These cookies allow you to move quickly and easily through a number of pages on a site and back without having to identify yourself on each page you visit or repeat processes (such as filling in a form). At the end of your browsing of the site or when you close your browser, but within a few hours at most, these cookies will be automatically deleted from your device.

## 2.6. Permanent cookies

Persistent cookies are cookies that remain "persistent" on your computer for a certain period of time (their validity period is defined in days, weeks, months or years) after the browsing process has expired, and therefore allow you to recall users' preferences or actions during a subsequent visit to the site (e.g. they can be used to store the data entered on a form on a given page). Until the expiry of the validity period, saved cookies are stored on your device, but you can delete them before the expiry of the predefined time limits.

## 2.7. Cookies from the website operator

Cookies from the server of the website you are browsing. In the present case, these are functional and convenient cookies from the server hosting the website operated by the Data Controller, the general characteristics and functioning of which are described above. These cookies record the IP address of your device, the pages you visit when using the website, and possibly (at your choice) the data you enter. This is to allow you to avoid having to repeat the process of opening a new page or returning to the site after leaving the site, opening the same pages or, at your option, re-entering data, when using the site.

We use cookies to provide registered users of our website with the appropriate permissions; once a user has logged in to the website, they will be given the necessary permissions. No other information is stored by these cookies in this context, including when you logged in, who logged in, and we simply use them to check your access rights.

These cookies are known as session cookies and are valid during your browsing session. This means that when someone starts browsing the site, the cookie is activated and then persists for up to a few hours after the user's last activity, or expires when the user exits.

An exception to this is a cookie that remembers your login data at your discretion, which is stored on your browsing device for 365 days.

## 2.8. Third-party cookies

Third party cookies are not from the Data Controller or the server hosting the website. These cookies are also stored on your computer, phone or tablet when you visit the site, as described below.

### 2.8.1. Visit analysis

The files from Google, TikTok, PixelYourSite, Powr help to monitor the site and provide information on how the site is used (such as the number of visitors to the site, the pages viewed, the country of the visitors - where the user is browsing from, where the user is "coming from" - from which other site -, the browser used, the operating system, the internet service provider and the resolution of the monitor used, the time the user browsed the site, when the user left the site). This information is used to generate statistics and to further improve the site.

The visit analysis, with the settings we use, results in anonymous statistical data alone, which does not identify your device (and you). However, Google Ireland Ltd., TikTok Technology Limited, MINIMAL WORK S.R.L. (Pixelyoursite), POWR Inc., who provide analytics cookies, may be able to identify your device and you in

relation to the other services they provide directly to you. This is the case, for example, if you visit our website in the same browser in which you are logged in with your Google Account. However, we will not be able to identify you or your device in such a case.

The data collected in this way will therefore be processed by Google Ireland Ltd. (Gordon House, Barrow Street, Dublin 4, Ireland), TikTok Technology Limited (10 Earlsfort Terrace, Dublin, D02 T380, Ireland), MINIMAL WORK S.R.L. (PixelYourSite - Comuna Bujoreni, Nr. 145, Județ Vâlcea, Sat Olteni, Romania), POWR Inc. (44 Tehama Street, San Francisco 94105, USA), Google, TikTok, PixelYourSite, Powr, the owner and operator of the assets of PixelYourSite, Powr.

If you have consented to the collection of browsing data for marketing purposes, Google Ireland Ltd, TikTok Technology Limited, MINIMAL WORK S.R.L. (PixelYourSite), POWR Inc. will also use the above data for their own purposes to deliver targeted advertising to the browsing user. In doing so, the above service providers determine the interests that can be identified based on the browsing habits of the device in question by combining the data collected by the cookies with the IP address of the browsing device used to browse the site, and then deliver targeted advertising to that device.

Cookies for marketing purposes only work with your consent, so that your device is identified when the data is collected.

(hereinafter collectively referred to as "Service Providers") provide online marketing services using cookies and pixels. Through these services, the Service Providers have access to a range of data processed to measure website traffic and to map browsing habits, as described above. This data is permanently stored on the Service Providers' equipment by means of cookies which are stored on the User's browsing device for a maximum period of 13 months. The User can delete these cookies in his browser settings. Nothing is stored in your browser when pixel data is collected. The Service Providers also use the above data to deliver targeted advertising to the browsing user. In doing so, the Service Providers will determine the interests that can be identified based on the browsing patterns of the device you are browsing from by combining the data collected by the cookies and the pixel with your browser ID or the IP address of the device you are browsing from, and then deliver targeted advertising to that device.

Such cookies will only work on the site with your consent.

### **3. Our use of cookies on our website and the processing of data through the use of log files**

- 3.1. Data subjects: all Users visiting the website, subject to the consent they have given.
- 3.2. Legal basis for data processing: with regard to data processing that is technically necessary for the provision of the service, Article 13/A (3) of Act CVIII of 2001 on certain issues of electronic commerce services and information society services (hereinafter: Act on Electronic Commerce) authorises the Data Controller to process the data necessary for the proper operation of the website. Such data is processed by means of log files and certain cookies. You can read more about log files in Chapter 4 and about the cookies concerned below.

The legal basis for the processing of such data as set out above is the legitimate interest of the Controller pursuant to Article 6(1)(f) of the GDPR.

We use this legal basis only to process data that is necessary for the user-friendly operation of the website, and we process this data only for the time necessary for this purpose. This is technical data (e.g. IP address, type of browser used and screen resolution) which is necessary for the enjoyable presentation of the pages of the website and for the proper use of its functions and for your convenience. The data will not be transferred to third parties or processed for any other purpose. In this respect, the processing of this data does not entail any risk for you, but the above-mentioned purpose - the proper use of the website - cannot be achieved without the processing of this data. It is in our legitimate interest to ensure the usability of the website, as this is the only way to make our services available electronically. Ensuring the availability of our website is essential for our effective operation. Therefore, we process the above data on the basis of our legitimate interest in achieving the purpose set out here, which, since the processing does not involve any risk to you, is a proportionate restriction of your right of self-determination.

The legal basis for the processing of data for marketing activities and for the analysis of visits is your consent pursuant to Article 6(1)(a) of the GDPR. You may consent to the collection of data for marketing purposes and for the purpose of traffic analysis by ticking the box in the information window that appears when you start browsing the website. Although we do not process any personal data based on the visit analytics data, because Google, TikTok, PixelYourSite, Powr can potentially identify you, we can only use visit analytics with your consent.

### 3.3. Scope of data processed:

The data processed to enable user-friendly browsing:

- the websites visited during your visit to the website and the order in which they are opened
- the IP address of the device you are using.

Scope of data processed for online marketing activities:

- the frequency with which you view each web page on the site and the time you spend browsing each page,
- the above conclusions about your interests,
- your browser ID.

Where data processed to control access to the website is stored (may be stored at your choice):

- your email address (as username) or username,
- password,
- the IP address of the device you are using.

The visit analysis is carried out by collecting anonymous data, so we do not process personal data in this context.

### 3.4. The purpose of the processing is to ensure the user-friendly and secure operation of the website and to carry out online marketing activities.

Including:

a) Necessary and functional data processing ("Necessary" and "Functional" categories in the pop-up window):

- Identification of the device used for your browsing, remembering the identification data for the duration of your browsing: based on the IP address. This makes your browsing experience smoother, without it you would have to identify yourself or repeat processes on every page you visit.

b) Processing of browsing habits: the following data required for the following purposes are recorded by us anonymously and cannot be linked to an individual. In this case, we do not process your personal data.

- To measure the number of visits to the website, to measure the frequency with which each page of the website is viewed and to measure the time spent browsing each page of the website in order to tailor the website to the needs of users and to understand their interests.
- Approximate location of your browsing device (part of the country) to map the territorial distribution of interest in our service.
- Identification of the website from which you came to this site in order to learn about other topics of interest to those interested in our service.

By collecting the above anonymous data, we can measure the visibility of our service, the effectiveness of our marketing activities and make them more effective.

We use tools from Google Ireland Ltd, TikTok Technology Limited, MINIMAL WORK S.R.L. (PixelYourSite) and POWR Inc. to collect this information. When you visit our website's web pages, cookies remember your preferences and information, which also allows us to collect anonymous data that we use to measure your visit to our website and to map your browsing habits.
